Fundraising and Tax Deduction Guidelines

Any business agreeing to donate a portion of any proceeds of its sales to a team (percentage of a night’s sales at a restaurant, for example), must make this donation directly to TPN to qualify for any tax deduction as permitted by law. If the event was organized and/or promoted in conjunction with a team, the team will receive credit (in their team totals).

Events with a *quid pro quo* do not entitle the buyer to a tax deduction even though the purchase is in support of TPN. This includes anyone who purchases a dinner at a restaurant fundraiser where the restaurant will later donate to TPN.

Donations of cash, made by individuals or businesses in support of Steppin’ Up (or TPN in general) with no goods or services received by the donor, may be tax deductible as permitted by law. Please contact TPN if a donor needs a tax receipt.
